FINAL AWARD


Claimants Richard S. Golden Revocable Trust and Golden Optical Corporation (collectively "Golden") bring a claim in arbitration against Respondent GenSpring Family Offices. The arbitration hearing was conducted June 4-8, 2012 in Miami, Florida. Having considered the testimony, exhibits, arguments and briefs of counsel, the undersigned arbitrator hereby makes the following Final Award.

Consistent with the post-hearing briefs, the arbitrator finds that Golden is entitled to recover losses of \$1,974,563.00, together with pre-award interest of \$31,997.00 and no post-award interest.

Consistent with the post-hearing briefs, the arbitrator also finds that Golden is entitled to rescission, and no pre- or post-award interest, with respect to investments which remain in two Silver Creek funds which have not been redeemed. It appears that the rescission amount is \$2,544,526.00.

The arbitrator finds that Golden is not entitled to an award of attorneys' fees or expenses.
