**Reverse Exchangeable Notes linked to Baker Hughes, Inc.**

**Description**

Bank of Montreal issued \$79,000 of Reverse Exchangeable Notes linked to Baker Hughes, Inc. on March 16, 2012 at \$1,000 per note.

These notes are Bank of Montreal-branded reverse convertibles. Reverse convertibles pay periodic interest coupons and at maturity convert into shares of the reference security if the price of the reference stock at the notes' maturity is below its price when the notes were issued and had closed below a specified "trigger" during the term of the notes.

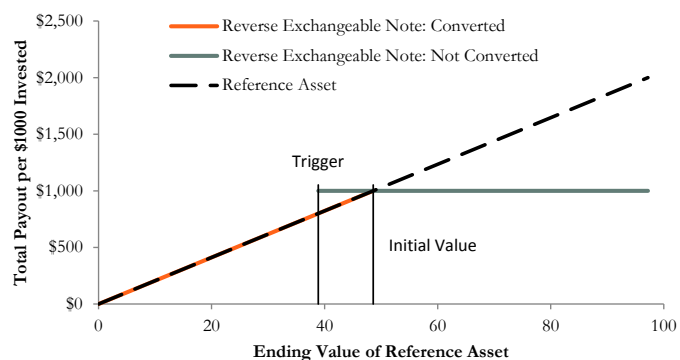
These 6-month notes pay monthly coupons at an annualized rate of 10.50%. In addition to the monthly coupons, at maturity on September 18, 2012 investors will receive the market value of 20.58 shares of Baker Hughes, Inc.'s stock if on September 13, 2012 Baker Hughes, Inc.'s stock price closes below \$48.60 (Baker Hughes, Inc.'s stock price on March 13, 2012) and had ever closed at or below \$38.88 during the term of the notes. Otherwise, investors will receive the \$1,000 face value per note.

**Valuation**

This Bank of Montreal reverse convertible linked to Baker Hughes, Inc.'s stock can be valued as a combination of a note from Bank of Montreal and a short down-and-in, at-the-money put option on Baker Hughes, Inc.'s stock. For reasonable valuation inputs this note was worth \$953.58 per \$1,000 when it was issued on March 16, 2012 because investors were effectively being paid only \$41.08 for giving Bank of Montreal an option which was worth \$87.50.

There is no active secondary market for most structured products. Structured products, including this note, therefore are much less liquid than simple stocks, bonds, notes and mutual funds. Investors are likely to receive less than the structured product's estimated market value if they try to sell the structured product prior to maturity. Our valuations do not incorporate this relative lack of liquidity and therefore should be considered an upper bound on the value of the structured product.

**Payoff Curve at Maturity**



The payoff diagram shows the final payoff of this note given Baker Hughes, Inc.'s stock price (horizontal axis). For comparison, the dashed line shows the payoff if you invested in Baker Hughes, Inc.'s stock directly.

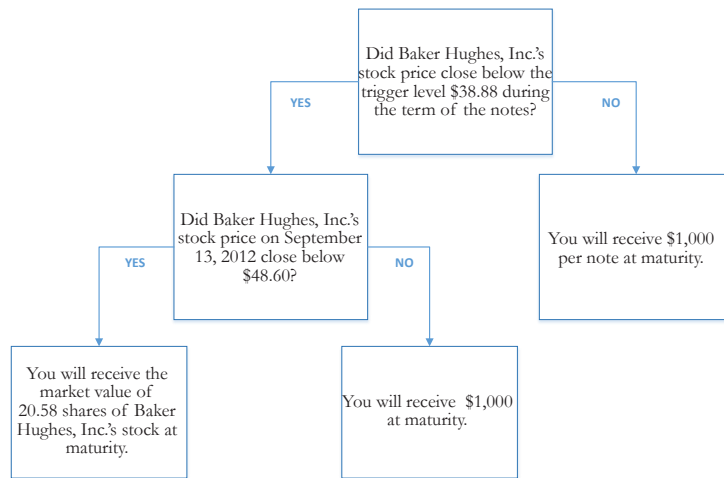

**Analysis**

This reverse convertible's 10.50% coupon rate is higher than the yield Bank of Montreal paid on its straight debt but, in addition to Bank of Montreal's credit risk, investors bear the risk that they will receive shares of Baker Hughes, Inc.'s stock when they are worth substantially less than the face value of the note at maturity.

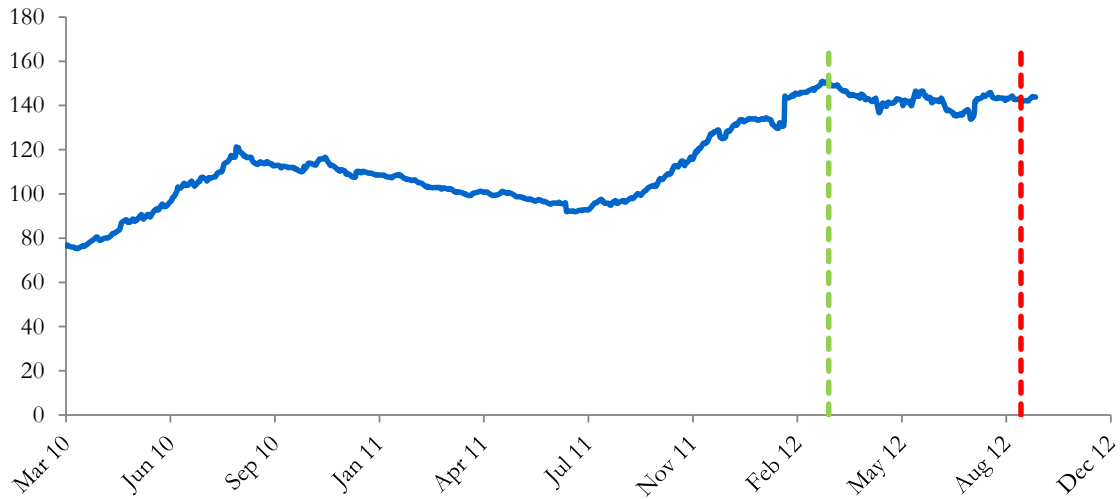
Investors purchasing reverse convertibles effectively sell put options to Bank of Montreal and post the note's issue price as collateral to secure satisfaction of the investors' obligations under the option contracts. Bank of Montreal pays investors a "coupon" that is part payment for the put options and part interest on the investors' posted collateral. This reverse convertible is fairly priced if and only if the excess of the reverse convertible's "coupon rate" above the interest Bank of Montreal pays on its straight debt equals the value of the put option investors are giving to Bank of Montreal. Whether the reverse convertible is suitable or not is equivalent to whether selling put options on the reference stock at the option premium being paid by Bank of Montreal was suitable for the investor.

**Bank of Montreal's Stock Price**



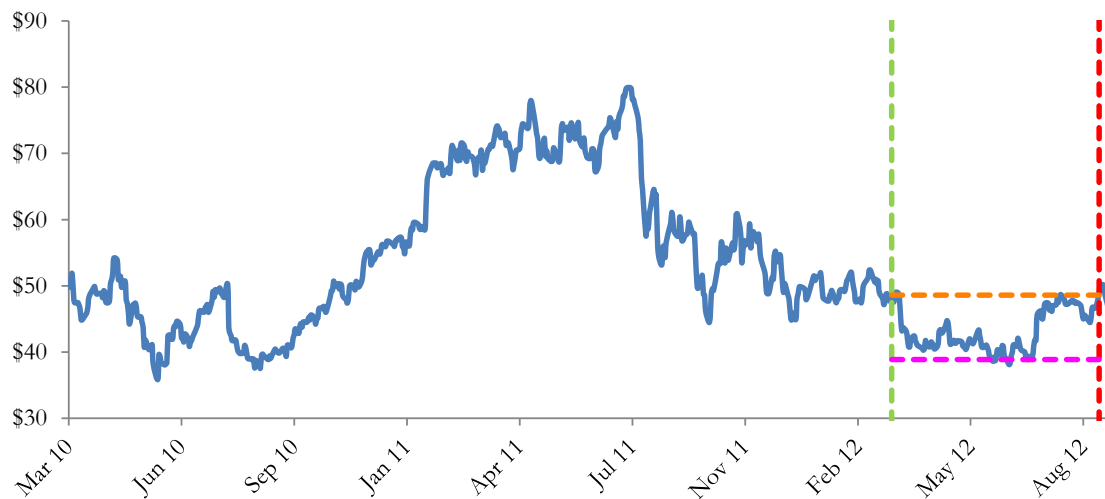
*The graph above shows the adjusted closing price of the issuer Bank of Montreal for the past several years. The stock price of the issuer is an indication of the financial strength of Bank of Montreal. The adjusted price shown above incorporates any stock split, reverse stock split, etc.*

### Bank of Montreal's CDS Rate



Credit default swap (CDS) rates are the market price that investors require to bear credit risk of an issuer such as Bank of Montreal. CDS rates are usually given in basis points (bps). One basis point equals 0.01%. Higher CDS rates reflect higher perceived credit risk, higher required yields, and therefore lower market value of Bank of Montreal's debt, including outstanding Reverse Exchangeable Note. Fluctuations in Bank of Montreal's CDS rate impact the market value of the notes in the secondary market.

### Baker Hughes, Inc.'s Stock Price



The graph above shows the historical levels of Baker Hughes, Inc.'s stock for the past several years. The final payoff of this note is determined by Baker Hughes, Inc.'s stock price at maturity. Higher fluctuations in Baker Hughes, Inc.'s stock price correspond to a greater uncertainty in the final payout of this Reverse Exchangeable Note.

### Realized Payoff

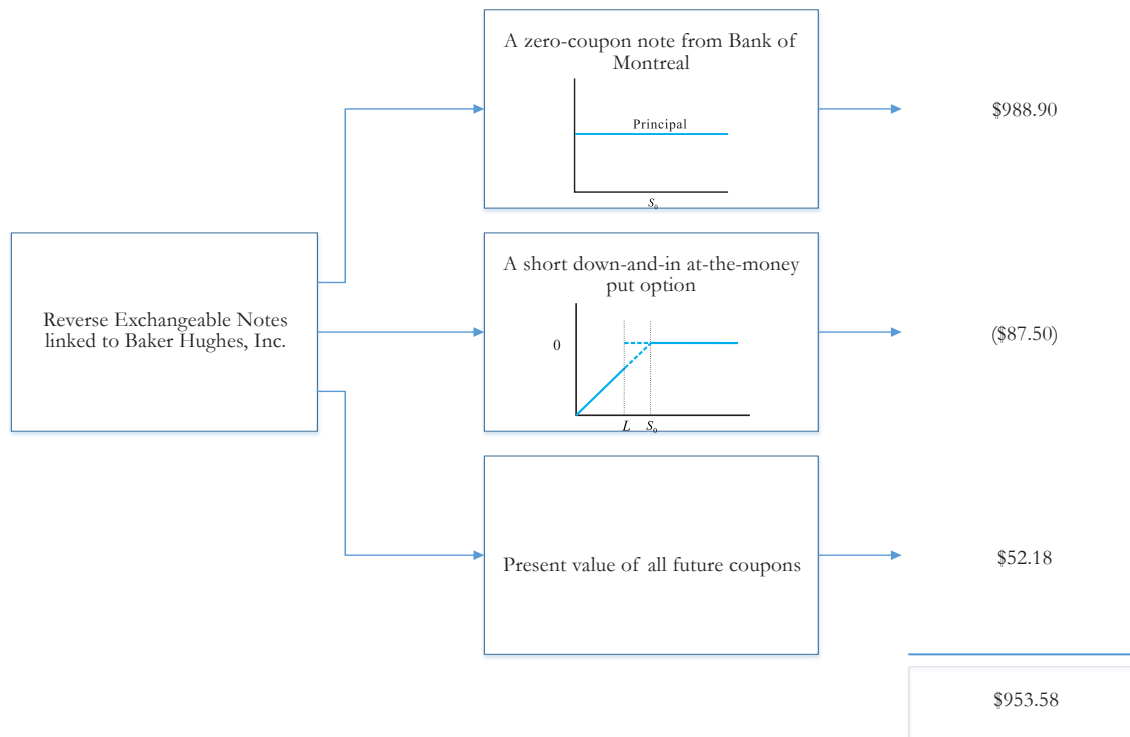
This note matured on September 18, 2012 and investors received \$1,000.00 per note.

## Reference Asset Baker Hughes, Inc.'s Stock's Implied Volatility



The annualized implied volatility of Baker Hughes, Inc.'s stock on March 13, 2012 was 35.23%, meaning that options contracts on Baker Hughes, Inc.'s stock were trading at prices that reflect an expected annual volatility of 35.23%. The higher the implied volatility, the larger the expected fluctuations of Baker Hughes, Inc.'s stock price and of the Note's market value during the life of the Notes.

## Decomposition of this Reverse Exchangeable Note



This note can be decomposed into different components, and each component can be valued separately. The chart above shows the value of each component of this Reverse Exchangeable Note.

1. Delta measures the sensitivity of the price of the note to the Baker Hughes, Inc.'s stock price on March 13, 2012.
2. CDS rates can be considered a measure of the probability that an issuer will default over a certain period of time and the likely loss given a default. The lower the CDS rate, the lower the default probability. CDS rate is given in basis points (1 basis point equals 0.01%), and is considered as a market premium, on top of the risk-free rate, that investors require to insure against a potential default.
3. Fair price evaluation is based on the Black-Scholes model of the Baker Hughes, Inc.'s stock on March 13, 2012.
4. Calculated payout at maturity is only an approximation, and may differ from actual payouts at maturity.
5. Our evaluation does not include any transaction fees, broker commissions, or liquidity discounts on the notes.
