Dual Directional Buffered Return Enhanced Notes linked to S&P 500 Index

Description

Credit Suisse issued \$7.00 million of Dual Directional Buffered Return Enhanced Notes linked to S&P 500 Index on March 4, 2009 at \$1,000 per note.

These notes are Credit Suisse-branded Buffered PLUS securities that do not pay periodic coupons, but instead pay a single amount at maturity depending on the final level of the S&P 500 Index.


If on August 27, 2009 the S&P 500 Index level is higher than 735.09, but lower than 778.64, the notes pay a return equal to the percentage increase in the S&P 500 Index multiplied by 2.0, up to a cap of 11.85%. If on August 27, 2009 the refe is below 735.09 but not below 661.58, investors receive \$1,000 face value per note. If the S&P 500 Index level on August 27, 2009 is lower than 661.58, investors receive face value per note reduced by 1.11 times the amount the reference asset is below 661.58 as a percent of the initial level, 735.09.

Valuation

This product can be valued as a combination of a note from Credit Suisse, 1.11 short outof-the-money put options, two long at-the-money call options, and two short out-of-themoney call options. For reasonable valuation inputs this note was worth \$952.80 when it was issued on March 4, 2009 because the value of the options investors gave Credit Suisse plus the interest investors would have received on Credit Suisse's straight debt was worth \$47.20 more than the options investors received from Credit Suisse.

There is no active secondary market for most structured products. Structured products, including this note, therefore are much less liquid than simple stocks, bonds, notes and mutual funds. Investors are likely to receive less than the structured product's estimated market value if they try to sell the structured product prior to maturity. Our valuations do not incorporate this relative lack of liquidity and therefore should be considered an upper bound on the value of the structured product.

Payoff Curve at Maturity



The payoff diagram shows the final payoff of this note given the S&P 500 Index level (horizontal axis). For comparison, the dashed line shows the payoff if you invested in the S&P 500 Index directly.



Maturity Payoff Diagram




The contingent payoffs of this Dual Directional Buffered Return Enhanced Note.


Analysis


This Dual Directional Buffered Return Enhanced Note pays investors the increase in the S&P 500 Index multiplied by 2.0 capped at 11.85%, but if the S&P 500 Index declines over the term of the note, investors will suffer losses equal to the percentage decline in the S&P 500 Index. In addition, investors bear the credit risk of Credit Suisse. Investors purchasing this Dual Directional Buffered Return Enhanced Note effectively sell at-the-money put and out-of-the-money call options to Credit Suisse, buy at-the-money call options, and a zero-coupon note from Credit Suisse. This Dual Directional Buffered Return Enhanced Note is fairly priced if and only if the market value of the options investors gave Credit Suisse plus the interest investors would have received on Credit Suisse's straight debt.

Credit Suisse's Stock Price




The graph above shows the adjusted closing price of the issuer Credit Suisse for the past several years. The stock price of the issuer is an indication of the financial strength of Credit Suisse. The adjusted price shown above incorporates any stock split, reverse stock split, etc.





Credit default swap (CDS) rates are the market price that investors require to bear credit risk of an issuer such as Credit Suisse. CDS rates are usually given in basis points (bps). One basis point equals 0.01%. Higher CDS rates reflect higher perceived credit risk, higher required yields, and therefore lower market value of Credit Suisse's debt, including outstanding Dual Directional Buffered Return Enhanced Note. Fluctuations in Credit Suisse's CDS rate impact the market value of the notes in the secondary market.




The S&P 500 Index Level

The graph above shows the historical levels of the S&P 500 Index for the past several years. The final payoff of this note is determined by the S&P 500 Index level at maturity. Higher fluctuations in the S&P 500 Index level correspond to a greater uncertainty in the final payout of this Dual Directional Buffered Return Enhanced Note.

Realized Payoff


This note matured on September 1, 2009 and investors received \$1,118.50 per note.

Reference Asset The S&P 500 Index's Implied Volatility



The annualized implied volatility of the S&P 500 Index on February 27, 2009 was 38.58%, meaning that options contracts on the S&P 500 Index were trading at prices that reflect an expected annual volatility of 38.58%. The higher the implied volatility, the larger the expected fluctuations of the S&P 500 Index level and of the Note's market value during the life of the Notes.

Decomposition of this Dual Directional Buffered Return Enhanced Note



This note can be decomposed into different components, and each component can be valued separately. The chart above shows the value of each component of this Dual Directional Buffered Return Enhanced Note.

- Delta measures the sensitivity of the price of the note to the the S&P 500 Index level on February 27, 2009.
 CDS rates can be considered a measure of the probability that an issuer will default over a certain period of time and the likely loss given a default. The lower the CDS rate, the lower the default probability. CDS rate is given in basis points (1 basis point equals 0.01%), and is considered as a market premium, on top of the risk-free rate, that investors require to insure against a potential default.
 Fair price evaluation is based on the Black-Scholes model of the the S&P 500 Index on February 27, 2009.
 Calculated payout at maturity is only an approximation, and may differ from actual payouts at maturity.
