Capped Leveraged Buffered S&P 500-Linked Notes linked to S&P 500 Index

Description

Deutsche Bank issued \$5.60 million of Capped Leveraged Buffered S&P 500-Linked Notes linked to S&P 500 Index on February 18, 2014 at \$1,000 per note.

Structured Products Research Report

These notes are Deutsche Bank-branded Buffered PLUS securities that do not pay periodic coupons, but instead pay a single amount at maturity depending on the final level of the S&P 500 Index.


If on February 10, 2016 the S&P 500 Index level is higher than 1,799.84, but lower than 2,077.92, the notes pay a return equal to the percentage increase in the S&P 500 Index, up to a cap of 15.45%. If on February 10, 2016 the refe is below 1,799.84 but not below 1619.86, investors receive \$1,000 face value per note. If the S&P 500 Index level on February 10, 2016 is lower than 1619.86, investors receive face value per note reduced by 1.11 times the amount the reference asset is below 1619.86 as a percent of the initial level, 1,799.84.

Valuation

This product can be valued as a combination of a note from Deutsche Bank, 1.11 short out-of-the-money put options, one long at-the-money call option, and one short out-of-the-money call option. For reasonable valuation inputs this note was worth \$962.83 when it was issued on February 18, 2014 because the value of the options investors gave Deutsche Bank plus the interest investors would have received on Deutsche Bank's straight debt was worth \$37.17 more than the options investors received from Deutsche Bank.

There is no active secondary market for most structured products. Structured products, including this note, therefore are much less liquid than simple stocks, bonds, notes and mutual funds. Investors are likely to receive less than the structured product's estimated market value if they try to sell the structured product prior to maturity. Our valuations do not incorporate this relative lack of liquidity and therefore should be considered an upper bound on the value of the structured product.

Payoff Curve at Maturity



The payoff diagram shows the final payoff of this note given the S&P 500 Index level (horizontal axis). For comparison, the dashed line shows the payoff if you invested in the S&P 500 Index directly.



Maturity Payoff Diagram




The contingent payoffs of this Capped Leveraged Buffered S&P 500-Linked Note.

Analysis


This Capped Leveraged Buffered S&P 500-Linked Note pays investors the increase in the S&P 500 Index capped at 15.45%, but if the S&P 500 Index declines over the term of the note, investors will suffer losses equal to the percentage decline in the S&P 500 Index. In addition, investors bear the credit risk of Deutsche Bank. Investors purchasing this Capped Leveraged Buffered S&P 500-Linked Note effectively sell at-the-money put and out-of-the-money call options to Deutsche Bank, buy at-the-money call options, and a zero-coupon note from Deutsche Bank. This Capped Leveraged Buffered S&P 500-Linked Note is fairly priced if and only if the market value of the options investors received from Deutsche Bank equals the market value of the options investors gave Deutsche Bank plus the interest investors would have received on Deutsche Bank's straight debt.

Deutsche Bank's Stock Price




The graph above shows the adjusted closing price of the issuer Deutsche Bank for the past several years. The stock price of the issuer is an indication of the financial strength of Deutsche Bank. The adjusted price shown above incorporates any stock split, reverse stock split, etc.

Deutsche Bank's CDS Rate



Credit default swap (CDS) rates are the market price that investors require to bear credit risk of an issuer such as Deutsche Bank. CDS rates are usually given in basis points (bps). One basis point equals 0.01%. Higher CDS rates reflect higher perceived credit risk, higher required yields, and therefore lower market value of Deutsche Bank's debt, including outstanding Capped Leveraged Buffered S&P 500-Linked Note. Fluctuations in Deutsche Bank's CDS rate impact the market value of the notes in the secondary market.




The S&P 500 Index Level

The graph above shows the historical levels of the S&P 500 Index for the past several years. The final payoff of this note is determined by the S&P 500 Index level at maturity. Higher fluctuations in the S&P 500 Index level correspond to a greater uncertainty in the final payout of this Capped Leveraged Buffered S&P 500-Linked Note.

Realized Payoff


This product will mature on February 16, 2016.

Reference Asset The S&P 500 Index's Implied Volatility



The annualized implied volatility of the S&P 500 Index on February 10, 2014 was 17.19%, meaning that options contracts on the S&P 500 Index were trading at prices that reflect an expected annual volatility of 17.19%. The higher the implied volatility, the larger the expected fluctuations of the S&P 500 Index level and of the Note's market value during the life of the Notes.

Decomposition of this Capped Leveraged Buffered S&P 500-Linked Note



This note can be decomposed into different components, and each component can be valued separately. The chart above shows the value of each component of this Capped Leveraged Buffered Score 9500-Linked Note.

- Delta measures the sensitivity of the price of the note to the the S&P 500 Index level on February 10, 2014.
 CDS rates can be considered a measure of the probability that an issuer will default over a certain period of time and the likely loss given a default. The lower the CDS rate, the lower the default probability. CDS rate is given in basis points (1 basis point equals 0.01%), and is considered as a market premium, on top of the risk-free rate, that investors require to insure against a potential default.
 Fair price evaluation is based on the Black-Scholes model of the the S&P 500 Index on February 10, 2014.
 Calculated payout at maturity is only an approximation, and may differ from actual payouts at maturity.
 Our evaluation does not include any transaction fees, broker commissions, or liquidity discounts on the notes.
