# Buffered Accelerated Market Participation Securities linked to iShares FTSE China 25 Index Fund

Structured Products Research Report

# Description

HSBC issued \$263,000 of Buffered Accelerated Market Participation Securities linked to iShares FTSE China 25 Index Fund on August 27, 2010 at \$1,000 per note.

These notes are HSBC-branded Buffered PLUS securities that do not pay periodic coupons, but instead pay a single amount at maturity depending on the final level of iShares FTSE China 25 Index Fund.


If on November 25, 2011 iShares FTSE China 25 Index Fund's share price is higher than \$39.58, but lower than \$43.44, the notes pay a return equal to the percentage increase in iShares FTSE China 25 Index Fund multiplied by 2.0, up to a cap of 19.50%. If on November 25, 2011 the refe is below \$39.58 but not below \$35.62, investors receive \$1,000 face value per note. If iShares FTSE China 25 Index Fund's share price on November 25, 2011 is lower than \$35.62, investors receive face value per note reduced by the amount the reference asset is below \$35.62 as a percent of the initial level, \$39.58.

### Valuation

This product can be valued as a combination of a note from HSBC, one short out-of-themoney put option, two long at-the-money call options, and two short out-of-the-money call options. For reasonable valuation inputs this note was worth \$951.50 when it was issued on August 27, 2010 because the value of the options investors gave HSBC plus the interest investors would have received on HSBC's straight debt was worth \$48.50 more than the options investors received from HSBC.

There is no active secondary market for most structured products. Structured products, including this note, therefore are much less liquid than simple stocks, bonds, notes and mutual funds. Investors are likely to receive less than the structured product's estimated market value if they try to sell the structured product prior to maturity. Our valuations do not incorporate this relative lack of liquidity and therefore should be considered an upper bound on the value of the structured product.

Payoff Curve at Maturity



The payoff diagram shows the final payoff of this note given iShares FTSE China 25 Index Fund's share price (horizontal axis). For comparison, the dashed line shows the payoff if you invested in iShares FTSE China 25 Index Fund directly.



#### Maturity Payoff Diagram




The contingent payoffs of this Buffered Accelerated Market Participation Security.


## Analysis

This Buffered Accelerated Market Participation Security pays investors the increase in iShares FTSE China 25 Index Fund multiplied by 2.0 capped at 19.50%, but if iShares FTSE China 25 Index Fund declines over the term of the note, investors will suffer losses equal to the percentage decline in iShares FTSE China 25 Index Fund. In addition, investors bear the credit risk of HSBC. Investors purchasing this Buffered Accelerated Market Participation Security effectively sell at-the-money put and out-of-the-money call options to HSBC, buy at-the-money call options, and a zero-coupon note from HSBC. This Buffered Accelerated Market Participation Security is fairly priced if and only if the market value of the options investors received from HSBC equals the market value of the options investors gave HSBC plus the interest investors would have received on HSBC's straight debt.

#### **HSBC's Stock Price**




The graph above shows the adjusted closing price of the issuer HSBC for the past several years. The stock price of the issuer is an indication of the financial strength of HSBC. The adjusted price shown above incorporates any stock split, reverse stock split, etc.



### HSBC's CDS Rate

Credit default swap (CDS) rates are the market price that investors require to bear credit risk of an issuer such as HSBC. CDS rates are usually given in basis points (bps). One basis point equals 0.01%. Higher CDS rates reflect bigher perceived credit risk, bigher required yields, and therefore lower market value of HSBC's debt, including outstanding Buffered Accelerated Market Participation Security. Fluctuations in HSBC's CDS rate impact the market value of the notes in the secondary market.




### iShares FTSE China 25 Index Fund's Share Price

The graph above shows the bistorical levels of iShares FTSE China 25 Index Fund for the past several years. The final payoff of this note is determined by iShares FTSE China 25 Index Fund's share price at maturity. Higher fluctuations in iShares FTSE China 25 Index Fund's share price correspond to a greater uncertainty in the final payout of this Buffered Accelerated Market Participation Security.

### **Realized Payoff**


This note matured on November 30, 2011 and investors received \$942.09 per note.





The annualized implied volatility of iShares FTSE China 25 Index Fund on August 24, 2010 was 30.91%, meaning that options contracts on iShares FTSE China 25 Index Fund were trading at prices that reflect an expected annual volatility of 30.91%. The higher the implied volatility, the larger the expected fluctuations of iShares FTSE China 25 Index Fund's share price and of the Note's market value during the life of the Notes.

#### Decomposition of this Buffered Accelerated Market Participation Security



This note can be decomposed into different components, and each component can be valued separately. The chart above shows the value of each component of this Buffered Accelerated Market Participation Security.

- Delta measures the sensitivity of the price of the note to the iShares FTSE China 25 Index Fund's share price on August 24, 2010.
  CDS rates can be considered a measure of the probability that an issuer will default over a certain period of time and the likely loss given a default. The lower the CDS rate, the lower the default probability. CDS rate is given in basis points (1 basis point equals 0.01%), and is considered as a market premium, on top of the risk-free rate, that investors require to insure against a potential default.
  Fair price evaluation is based on the Black-Scholes model of the iShares FTSE China 25 Index Fund on August 24, 2010.
  Calculated payout at maturity is only an approximation, and may differ from actual payouts at maturity.
